

“RANKO RADOVIĆ” AWARD RULES

Article 1

The award which bears the name of architect Ranko Radović was founded with the aim to encourage, develop and promote critical theoretical thought in the field of architecture and creativity in architecture, and thus establishing criteria for its evaluation in Serbia and at the international level, implying inclusion of former Yugoslav republics, as well as countries with which Ranko Radović has cooperated or in which he has worked.

Article 2

The founder of the Award is the Association of Applied Arts Artists and Designers of Serbia (ULUPUDS), and the co-founders are: Faculty of Architecture of Belgrade, Faculty of Technical Sciences in Novi Sad, Institute of Architecture and Urban & Spatial Planning of Serbia, Ilija Milosavljević Kolarac Foundation, Institute of Urbanism Belgrade, Company WIENERBERGER doo Kanjiža, Serbian Chamber of Engineers . and Radio Television of Serbia,

Article 3

The “Ranko Radović” Award consists of three recognition awards (in all fields in which “Ranko Radović” has worked) which are given for:

- 1) critical theoretical texts on architecture published in the preceding calendar year, as well as in the current year until the date of Award giving, for criticism, essays, books, lectures, and written word in general;
- 2) realized architectural work completed in the same period, and
- 3) TV shows, exhibitions or multimedia presentations completed in the same period

Article 4

The “Ranko Radović” Award Board shall be established and shall be composed of twelve (13) members. Four (4) members will be appointed by the Founder of the Award, i.e. two (2) members from the Section for History, Theory and Criticism of Art and two (2) from the Section for Architecture (whose member was Professor Ranko Radović), one (1) member shall be appointed by each of the co-founders, and one (1) member

shall be the representative of the Ranko Radović's family. Term of office of the Award Board members shall be four (4) years. Representatives of the Founder and Co-Founders may be art historians and theoreticians, as well as eminent persons from the field of culture (writers, painters, scientists...). The Award Board shall elect one of its members to serve as President.

Article 5

The Founder shall adopt these "Ranko Radović" Award Rules, while the Award Board shall appoint the "Ranko Radović" Award Jury, and shall also decide on activities related to award giving. The Award Board members may not be members of the Jury. The Jury members, their associates and their relatives may not compete for the Award.

Article 6

Proposals for the "Ranko Radović" Award may be made by individuals, institutions, associations, and Award Board members, while Jury members may not propose candidates for the Award. The competition for the Ranko Radovic Award can not compete with student works An advertisement shall be published in media, which implies inclusion of individuals, institutions and media from the former Yugoslav republics, as well as countries with which Ranko Radović has cooperated or in which he has worked.

Article 7

The Award Board shall appoint three juries for the "Ranko Radović" Award giving: a jury for critical theoretical texts on architecture published in the preceding calendar year, as well as in the current year until the date of the Award giving, for criticism, essays, books, lectures, and written word in general; a jury of the most important realized architectural work completed in the same period and a jury for TV shows, exhibitions or multimedia presentations realized during the same period. Each of the three appointed juries shall be composed of three (3) to five (5) members, who shall be art historians and theoreticians, critics and architects, as well as eminent public figures. A Jury member may perform this duty in only one of the three juries. The juries shall work independently

of each other. Term of office of the Jury members shall be two (2) years. The decision on the Award shall be passed by the majority of the Jury members. Each of the Jury shall give one award only. If a member of the jury to decide the duration of the mandate of two years, competing for the prize, must withdraw from the jury and notify the Board in writing at least three months before announcement of competition for the award Ranko Radovic, or before the first of September of this year, when Regulations for the award and announced.

Article 8

The “Ranko Radović” Award consists of prize money and charters. The amount of prize money shall be established by the ULUPUDS depending on the resources collected from co-founders and donors. Printing of charters and organization of the Award giving shall be done by the Award Board. An account for collecting resources shall be opened through the ULUPUDS.

Article 9

The decision shall be announced and awards shall be presented on 21st September (the date on which Ranko Radović received his doctor’s degree from the Sorbonne-Paris) during the Award Ceremony. The decision on awards may not be announced in media prior to this date.

Article 10

The seat of the “Ranko Radović” Award Board shall be in the ULUPUDS. The decision on awards shall be submitted for an insight to the ULUPUDS Managing Board and Arts Council. These Rules were adopted at the ULUPUDS Annual Meeting on 23rd December 2006, while Amendments and Supplements to the Rules were adopted at the ULUPUDS Annual Meeting of 19th October 2008 and at the ULUPUDS Managing Board sessions of 5th October 2009, 17th February 2010. and 03 th November 2014.
